RE: FY-24 Supplemental Budget 2023-33; Exhibit A

ISSUE: The total sum of personnel services in the Planning Department did not total all the amounts correctly.

Additionally, the city is currently in the process of hiring a Finance Director and needs to outsource those duties in the interim.

Finally, the hummous pond at the wastewater treatment plant is in danger of overflowing creating an emergency situation. The pond needs to be pumped down to prevent an overflow into the nearby lake and creating a public health hazard. Public Works Superintendent has contacted a company that can pump half of the pond now for \$95,000.

RECOMMENDATION: Recognize that the total of the Planning Departments personnel is \$13,637 and approve a \$3,551 reduction to the Contingency account in non-department. This action is needed to bring the FY-24 Budget into balance.

Accept the following allocated costs to outsource the Finance Directors duties in the FY-24 Budget. A bid has been accepted by the City in an amount not to exceed \$40,784. It is recommended to allocate that cost to other funds in the same percentages as would be used for the Finance Director's wage. The amount allocated to each fund is as follows:

General Fund, Non-departmental, increase line "62160 Professional services" by \$12,291 and reduce line "98500 Contingency" by the \$12,291 to keep that fund in balance. The \$12,291 and \$3,551 equals a total change to "98500 Contingency" of \$15,842.

Parks Fund, Material and Services, line "62160 Professional Services" increase of \$3,357 and line "98500 Contingency" is reduced by \$3,357.

Public Safety Fund, Material and Services, line "62160, Contract Services" increase of \$3,967 and line "98500 Contingency" is reduced by \$3,967.

Water Enterprise Fund, Material and Services, line 62160, Contract Services" increase of \$8,416 and line "98500, Contingency" is reduced by \$8,416.

Sewer Enterprise Fund, Material and Services, line 62160, Contract Services" increase of \$12,163 and reduce "98500, Contingency" by the same \$12,163.

Street Fund, Material and Services, line 62160, Contract Services" increase of \$1,591 and line "98500, Contingency" is reduced by \$1,591.

It is recommended to include the pumping of the hummous pond in the FY-24 Sewer Enterprise budget by transferring \$95,000 spending authority from line "63201, Operating Loan – Water Enterprise" to line "62821 Repairs & Maint. – STP.

ACTION: Approve Resolution 2023-33 as outlined in Exhibit A to ensure that the budget remains in compliance with local budgeting laws.

FORMAT: The Appropriation Resolution Exhibit A uses the same format as the original budget that was adopted by the Council on June 15, 2023. The column titled "2023-2024 Council Adopted Budget" is the actual amount adopted by the Council on June 15, 2023. The next column is the proposed changes to the budget by this resolution and the last column titled "Appropriation Resolution 2023-33 is the net effect of those changes. I have included only the pages of the FY 24 budget that will be changed by this resolution along with a summation to show that all of the funds are still balanced.

RESOLUTION 2023-33

A RESOLUTION BY WHICH THE CITY OF PORT ORFORD MAKES APPROPRIATIONS AND ADJUSTMENTS TO THE 2023-2024 MUNICIPAL BUDGET THROUGH AN APPROPRIATION RESOLUTION.

WHEREAS, the State of Oregon ORS 294.463 allows a municipality to revise its annual budget through the adoption of an Appropriation Resolution, and

WHEREAS, unexpected events have occurred which could not have been ascertained at the time the 2023-2024 budget was prepared, and which necessitate adjustments to the General, Parks, Public Safety, Water, Sewer and Streets Funds, and

WHEREAS, a transfer of spending authority between categories in the aforementioned funds is necessary to ensure the budget remains in compliance with local budgeting laws, and

WHEREAS, these changes represent less than a ten percent change in funds;

NOW, THEREFORE,

BE IT RESOLVED by the *Common Council of the City of Port Orford* that the following addition to revenues and appropriations in the 2023-2024 Adopted Budget, as set forth in Exhibit A attached hereto, hereby be adopted:

HOLD HARMLESS CLAUSE: The licensee agrees that their performance under this permit is at their own sole risk and that they shall indemnify the City of Port Orford, its agents and employees and hold harmless from any and all liability for damages, costs, losses and expenses resulting from, arising out of, or in any way connected with this permit and from any loss arising from the licensee's use of the property, or from the licensee's failure to perform fully hereunder, and the licensee further agrees to defend the City of Port Orford, its agents, and employees, against all suits, actions or proceedings brought by any third party against them for which the permit holder would be liable hereunder.
