 - A. None
- 5. (0:04-0:33) E Clampus Vitus: Historical Marker
 - A. Darren Farris on behalf of E Clampus Vitus presents a proposed Plaque explaining the history of the Port to be installed on 5th St. near "Castaways". The Port has been a fixture in Port Orford for over 200 years and its rich history

should be recorded and on display. The Port Orford Historic Preservation Society has signed off on the contents of the plaque; it's all historically accurate.

- B. Commissioners ask if there was prior tribal use prior to the port or if they had received input from any of the tribal governments.
 - i. There is a comment at the top with some tribal history; trying to avoid entangling the history of the Port with the history of the tribes. Has not worked with any of the tribal governments.
- C. Commissioners would like to see more than 1 line dedicated to the indigenous people of the area that lived here prior to the existence of the City of Port Orford. They recommend reviewing materials on the website "Eco-Justice" to gain a broader perspective.
- D. Commissioners have grammatic/spelling suggestions.
- E. Commissioners recommend having the plaque put in place at the Visitor Center or on the Port itself instead of its current proposed location.

A. Technical Assistance Grant from DLCD: Housing Implementation

- i. Senior Planner Shoji goes through the current code and proposed revisions. Commissioners discuss definitions of Prefabricated Structure vs Prefabricated Dwelling and Dwelling vs Home. 1000 sq ft minimum requirement for manufactured homes is to be removed due to changes in state code. Tiny Homes are not defined in our code and there are no plans to add a definition for it. New regulations for RV parks are based on the Conditional Use Permit that was approved last year and state codes.
